

What are some emerging IP and IT law trends, and how do you see the legal landscape evolving in these areas over the next few years?

On the patent side, on January 26, 2024, the Unified Patent Court (UPC) and Italy reached a milestone with the finalisation of the Headquarters Agreement for the UPC's Central Division's third seat in Milan.

As a consequence, in addition to being the only Local Division in Italy, Milan hosts the third Central Division along with the Munich and Paris Divisions with jurisdiction over patent disputes in the "human necessities" sector, comprising the pharmaceutical and medical device industries, the agricultural industry, the food industry, the tobacco industry, the home appliances industry, the clothing industry, the wood and furniture industry, the fire-fighting industry, the sports and gaming industry.


Of course, that is an extremely important result for Italy and for Milan, one of the main European hubs in innovation and intellectual property and whose Central Division, in addition to the Local Division, will judge important Unitary Patent disputes from all the European countries which are part of the EU Patent Package.

One of the other main topics is artificial intelligence (AI) as a key area of growth and opportunity in the field of IP/IT law, as AI technology continues to advance at a rapid pace and is creating new legal challenges and opportunities for businesses across a wide range of industries.
